This is an application for a Hauler or Caretaker license to collect, accept, transfer, transport or deliver recyclables, separated food scraps & paper, and solid waste generated within the Windham Solid Waste Mgmt District (WSWMD).

All Haulers or Caretakers doing business within the WSWMD must complete this no-cost license application and display the WSWMD decal (provided by WSWMD) on each vehicle.

For Haulers, this license begins on August 1, 2021 and expires on July 31, 2022.

For Caretakers, this license begins on July 1, 2021 and expires on June 30, 2022.
